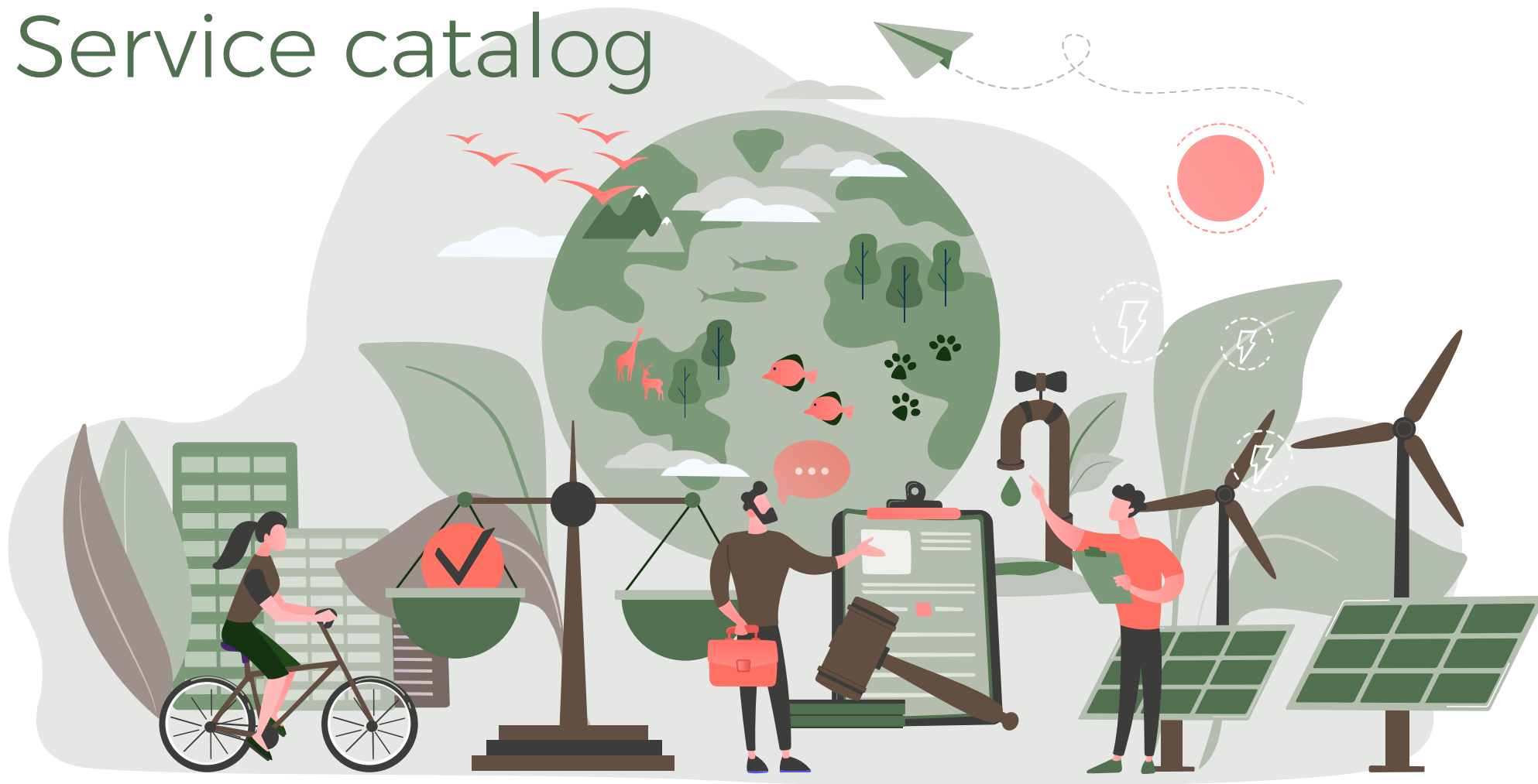

Consulting and advice for the public administration in drafting and reviewing environmental regulations.



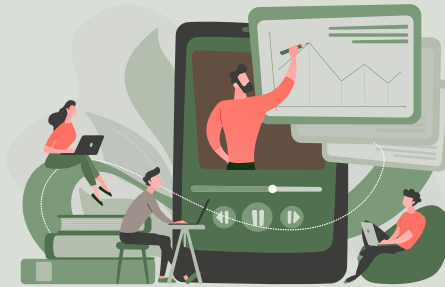
Environmental legal defense

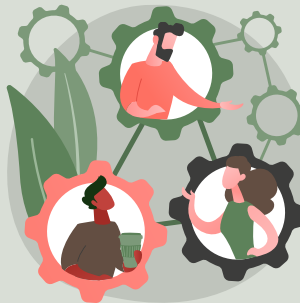


Accompanying in participatory processes
